History of establishment. "KazAgro" National management holding" JSC (hereinafter – the Holding) was established in accordance with the Decree of the President of the Republic of Kazakhstan dated December 11, 2006 No. 220 "On some issues of agribusiness complex development" and the Resolution of the Government of the Republic of Kazakhstan dated December 23, 2006 No. 1247 "On measures for implementation of the Decree of the President of the Republic of Kazakhstan dated December 11, 2006 No. 220".

By the Decree of the President of the Republic of Kazakhstan dated February 24, 2009 No. 748 "On amendment of the Decree of President of the Republic of Kazakhstan dated December 11, 2006 No. 220" and the Resolution of the Government of the Republic of Kazakhstan dated March 13, 2009 No. 297 "On amendment and addition to the Resolution of the Government of the Republic of Kazakhstan dated December 23, 2006 No. 1247" the Holding was assigned a status of a national management holding [1].



Strategic directions of development


- 1. Stimulating labor production growth from financing of high-technological (innovative) projects with se of modern agro-technologies.

Financing of agribusiness complex for 2007-2017




Picture 1: Total volume of agribusiness complex financing for 2007-2017 is growing steadily every year




Picture 2 - shows that volume of SME lending is 77%

Foreign direct investment is the investment of capital with a view to acquiring a long-term economic interest in the country of capital application, which ensures the control of the investor over the object of placement of capital. The main forms of foreign direct investment are the opening abroad of enterprises, including the establishment of subsidiaries or the opening of branches, the creation of joint ventures, the purchase of a controlling stake in the enterprises of the donor country and etc [1, 2].

Investment in the real sector of the national economy can lead and be the vehicle to realize the State Program of Rapid Industrial Innovative Development of Kazakhstan. Unfortunately, not always asked demand can be supplied in all spheres due to growing demand. That is why, foreign direct investment is important and can be solution to this. Namely because of this President of Kazakhstan Nursultan Nazarbayev made an emphasis on promotion of foreign investments in his address to the nation in 2012. He claimed that country should prepare legislation system that will create better business investment climate for attracting more foreign direct investment [3].
